



LIMITED LIFETIME WARRANTY

1. MB SPORTS warrants each new boat manufactured by it to be free from defects in material and workmanship under normal use and care for as long as the Original Purchaser owns the boat (not for resale). MB SPORTS or its selling dealer will, without charge, repair or replace, at MB SPORTS' option, any boat or portion thereof proven to its satisfaction to be in defect during the above warranty period. Warranty repairs will be done at the selling dealer's location or at the manufacturer of the boat provided that its transportation cost for both directions are prepaid and the claim is made within sixty (60) days after defect is discovered, or should have been discovered.

2. This warranty does not apply to:
 - A. Any product not manufactured by MB SPORTS, including but not limited to, engines, drives, instruments, fuel tanks, pumps, controls or other equipment or accessories installed by MB SPORTS, some of which may be covered by a separate warranty granted by the manufacturer of such parts.
 - B. Damage or effects of damage caused by the installation of engines, accessories or other equipment installed by anyone other than MB SPORTS.
 - C. Boats that have been sold or transferred by the original owner; boats that have been altered, overloaded, overpowered, or subject to accidents, misuse or negligent care.
 - D. Windshield breakage, colorfastness, gelcoat osmosis.
 - E. Any boat or portion thereof used for racing, governmental or commercial use or service.
 - F. Water damage, mildew damage, dry rot, absorption or condensation to interior or polyurethane foam system.
 - G. Cost or charges derived from inconveniences of loss of use, commercial or monetary loss due to time loss, or any other special or consequential damage of any kind or nature whatsoever.

3. To effect the foregoing warranty, it is the sole responsibility of the Original Purchaser to fill out, sign and return the warranty registration card within 15 days of the date of sale to:

4. Notification of claim or defect must be made in writing to MB SPORTS, directly or through the selling dealer. Include name and address of original retail purchaser, boat serial number (permanently embossed on the right-hand side of transom), date of original sale, detailed explanation of defect, and estimated cost of repair. Warranty repair or replacement will only be made after above information is compiled and a warranty authorization number is issued in writing or by telephone to original purchaser or approved warranty repair station.
5. The foregoing limited warranty is given in place of and instead of any and all expressed or implied guarantees of warranties, and may not be modified in whole or in part by anyone other than MB SPORTS.
6. This warranty gives you specific legal rights. In some states you may have other expressed or implied warranty rights. In the event of a problem with warranty service or performance, you may resort to procedures as may be set forth by the Federal Trade Commission.
